Start your e.banking in just a few easy steps.Court rejects sole claim in CBI petition on Hyderabad blast CHENNAI: On Wednesday, the Madras high court dismissed an appeal by the CBI against the trial court's acquittal of an accused in the Hyderabad serial blasts of 2005, making it a landmark verdict. The court in its order said CBI should not have taken the case on its own, rather relying on the police's probe as the agency was not involved in the probe. "There are no traces of any explosives either by the CBI itself, or by the police during the course of the investigation," Justice K Ravichandra Babu told a bench of justices N Kirubarajan and Arumugam. "It is a fact that the accused was acquitted by the trial court. The CBI has no locus to take the case on its own," Justice Ravichandra Babu said. The court also said that the CBI was not in a position to argue that the police's probe was weak because it was an investigation under the Criminal Procedure Code and the agency was in a different legal setting. The government had earlier said it had no objections to the acquittal in the case. The judge also noted that the evidence against the accused was
